There are also students who run out of internet quota and don't have money to buy. This is because in the implementation of online learning students are only given the task of doing evaluation questions and only occasionally practice, and the teacher does not know whether the students really understand or not. Given that students study at home accompanied by parents or guardians of students, so it is possible if the assignments of students are assisted by parents or guardians of students in working on questions at IMTERA.

## CONCLUSION

The ineffectiveness of the implementation of online learning through IMTERA in learning akidah akhlak in class IV MI Al-Barokah, the improvement given to make the implementation of online learning through IMTERA better is an increase in teacher creativity.
