#### **ABSTRACT**

The village medium-term development plan (RPJM desa) is one of the development planning documents that is required to be prepared for the village-level government by Law number 25 of 2004 concerning the National Development Planning System in the law which also mandates that 3 (three months after the head of the village is inaugurated the preparation of the village medium-term development plan (RPJM desa) must be completed and determined.

In this study, the author uses the website as an information system for the Village Government's Medium Term Development Plan to design an RPJM and carry out development activities needed by the village.

#### INTRODUCTION

The Law of the Republic of Indonesia Number 6 of 2014 concerning Villages in Article 79 Paragraph (1) states that the village government prepares long-term village development plans. Referring to the Regency/City development planning, namely the Village Medium-Term Development Plan (RPJMDes) for 6 years, and the Village Development Work Plan (RKP) for 1 (one) year. RKP Desa is an elaboration of the Village Medium-Term Development Plan (RPJMDes). (Sumarauw, et al, 2019)

What we must understand is that village development planning is carried out in 2 (two) processes, namely first, the village medium-term development plan (RPJM) with a period of 6 (six) years. conditions and needs of the local community. Thus, the process of exploring the ideas and aspirations of the community as well as identifying potentials, and problems and determining actions. Second, the Village Development Work Plan (RKP) with a period of 1 (year). The Village Medium-Term Development Plan (RPJM) is stipulated by village regulations and the Village Development Work Plan (RKP) is stipulated in a guided village head decision. In regional regulations, the RPJM and RKP Desa are planning documents in the village, and serve as guidelines in the preparation of the Village Budget which is regulated in a Government Regulation. Based on PP No. 43 of 2014 the Village RPJM or village RKP can be changed in terms of: due to special events such as natural disasters, political crises, economic crises, and/or there can be fundamental changes to the policies of the Government, provincial regional governments, and/or district governments /city. Changes to the RPJMDes and RKPDes are discussed in the musrenbang and are then stipulated by village regulations. (Maripah, 2017)

To achieve optimal development results, an innovation in development planning that can answer the strategic issues needed. This demand will be fulfilled if the role of innovation is carried out properly. Villages are structurally part of the lowest administrative system in Indonesia. The implementation of village development must also be based on the role of providing innovation. Since this law provides opportunities for villages to play an effective and effective role, then the role of the government apparatus is not only as a facilitator and service provider ("service provider") but also as a dynamist and entrepreneur. #### **METHOD**

#### RESULT AND DISCUSSION




Figure 1. Diagram System
